# **Beloit International Film Festival on for 2021**

The 16th Annual Beloit International Film Festival will look a little different this year. Taking its cue from the Toronto International Film Festival, BIFF organizers have opted to present an online festival this year.

With the cancellation of the Boone County Fair, Milk Days, indefinite postponement of the Chicago Auto Show and countless other disappointments, it's great to see the show safely go on and offer a break from the humdrum of everyday life.

The Festival has announced its 2021 lineup of about 100 films. Instead of screening them at the usual Downtown Beloit venues, they will be available on demand at the Festival website, www.beloitfilmfest.com. The films can be viewed any time during the festival, which runs from Friday, February 19 through Sunday, February 28.

The number of film festivals has proliferated, and yet Beloit is one of the top 100 festivals worldwide. Fewer than twenty percent of the films submitted to the festival end up making the final cut.

Filmmakers are lavish in their praise for the festival and its hospitality. Several have commented that Beloit audiences are engaged and ask thoughtful questions of them. Too often it seems, film festivals have filmmakers watching each other's films with little other interaction. That's not the case at Beloit, where films often play to a full house, even when additional screenings are offered.

Despite the enthusiastic audiences and popularity, Beloit remains a small, intimate festival held in a small, charming Midwestern city with plenty of restaurants and nightlife, all only 30 minutes away from home. Even the parking is easy.


To keep up that collegial Beloit spirit in pandemic times, video conferences with the filmmakers will be available for many films. You can video chat live with the filmmaker and ask questions. You can watch the film at your leisure, but of course you'll want to watch before the filmmaker conference. The full schedule of these meet-the-filmmaker events is published on the website.


#### How to BIFF 16.

In past years, you bought tickets in advance. This year, instead of advance tickets, you buy tickets when you are ready to see your film. Tickets can be purchased anytime, starting on Friday, February 19. Start by browsing the film index at beloitfilmfest.org. When you choose a film to see, you can head over to Ticket Information. Once there, you'll be prompted to buy a ticket. Each selection is \$10.



# The 16th Annual Beloit International Film Festival

The festival has about 100 films on offer, and it's often a difficult decision picking which ones to watch. Of the films I've seen, these eight strike me as good picks.

#### Freeland

# Rated PG-13, Directed by Kate McLean and Mario Furloni

Those who survived the sixties and seventies will appreciate the irony of this film. Back then, legalizing pot was a fringe view. Now that weed is legal in Illinois, if not yet in Wisconsin, a new issue has emerged: How does the old guard of long-time growers fit in with the new players in the cannabis trade?

The story takes place in Humboldt County, California, an area well-known and ideally suited for growing marijuana. The scenery and resulting cinematography is beautiful, and a real treat.

Devi (Kristina Fairchild) is silver-haired, oldtime marijuana grower who is about to bring in her best-ever crop so it can be transported to Nebraska (where it is still illegal). Growing pot is now legal in California, but as a tightly regulated industry. Harassed by local bureaucrats, Devi tries, but fails to become licensed as a grower. The fines and large investment required to go legal are prohibitive for her. Her Nebraska connection gets wind of her legal troubles and wants no part of her crop. Gradually, Devi's world collapses.

This film leaves you thinking about the cannabis industry and how it should be structured. Does it only belong to young, nimble entrepreneurs or should there be a place at the table for the experienced professionals who took risks and built the business?

The acting in the film is first-rate and Kristina Fairchild has already won best actress accolades at River Run and the Sidewalk Film Festivals. The rest of the cast does not disappoint.

Freeland has won Best Narrative Feature at the Atlanta and Bend Film Festivals and Winner of the New Directors Competition at the Nashville Film Festival as well as several other awards and nominations. It is sure to be in the running here.

#### Samaritan

#### United Kingdom. Rated PG-13 Directed by Dustin Curtis Murphy

This dystopic, British narrative film is only twelve minutes long, but tells a story worthy of a full-length feature. Dr. Saeed Ali (Chris Kyriacou) is an immigrant doctor fearing deportation. Prior to living in the city and working at a hospital, he is living off the grid in a woodland. He comes across the body of racist politician, Robert Harrington (Peter Ormond). Dr. Ali treats Harrington and saves his life.

Robert Harrington has a first-class ticket to board Samaritan I, a space station meant to support human life now that Planet Earth has been wasted and is no longer capable of supporting humans. Ungrateful, Harrington tries to leave Ali's cabin and collapses outdoors.

The climate crisis and bigotry directed against Dr. Ali make this apocalyptic film highly topical and relevant to our times. Dustin Curtis Murphy is an award-winning filmmaker with over twenty years' experience in the film industry. Samaritan has already won an Award of Excellence in the drama category at the Southern Shorts Awards, and was a semifinalist at the Academy Award-qualifying Rhode Island International Film Festival.

Samaritan will be shown along with a group of other short films in Short Slot 2.

#### Royalty Free: The Music of Kevin MacLeod

#### Rated PG-13, Directed by Ryan Camarda

Green Bay native Kevin MacLeod is one of the most heard composers in the world. Nearly everyone has heard his music but has probably never heard of him.

This documentary tells the story of how MacLeod releases his music for free. All MacLeod asks is that you give credit to his music. If you can't give him credit (such as in a commercial), he will license the music to you for a one-time token payment. It is a strategy that's made him rich and successful. If you have used his free music, he may be the guy you think of when you need paid work.

Free music is a boon for filmmakers and fledgling artists who often can't afford to hire studio musicians or pay a royalty. Many amateur You-Tubers and studio filmmakers use his tunes.

MacLeod distributes his music at a website, Incompetech.com. After watching the film, I went over to the website and checked it out. Sure enough, I recognized at least two tunes, one I had heard waiting on hold the previous week. While writing this review, I found myself listening to some of his music online.

The film touches on MacLeod's personal life and discusses the controversy that surrounds MacLeod's distribution model. MacLeod's electronically produced free music is a threat to many studio musicians and their livelihoods. Is this good for the art? Rather dismissively, McLeod

compares his work to what happens to momand-pop retailers when Walmart comes to town.

Royalty Free is informative and has a good discussion of the issues and times that the music industry is facing. It is a bit long in spots, but the fascinating subject compensates for the lag.

#### **Drought**

#### Rated PG, Directed by Hannah Black and Megan Petersen

Drought takes place in rural North Carolina in 1993, when the state was experiencing a record dry spell. Estranged older sister Lillian (Megan Petersen) comes by to check on Sam (Hannah Black) and Carl (Owen Scheid), because their Mother Lorraine (Jane McNeill) has been arrested on a marijuana charge and is in jail. Carl is a 17-year-old, autistic young man with a strong interest in meteorology. Carl believes that a storm is imminent and wants to chase it. His sister Sam facilitates that by "borrowing" their Mother Lorraine's ice cream truck for a road trip. Lillian, Sam, Carl, and friend Lewis (Drew Scheid)--who appears not to have much of a family life--ultimately set out together.

Black and Peterson play realistic sisters while doing an outstanding job of directing this coming-of-age road trip. Family tensions are convincingly portrayed. The cinematography and musical soundtrack are enjoyable. During the trip, the four gradually put aside their differences and become friends. The siblings and Lewis gradually talk out their differences and come to understand each other better.

Drought asks, "What is normal, anyway"?

Drought won the People's Choice Award at the Vail Film Festival.

#### **Gossamer Folds**

#### Rated PG, Directed by Lisa Donato

It's the summer of 1986. Nine-year old Tate (Jackson Robert Scott) moves to the suburbs of Kansas City. Tate, an only child whose constant companion is the dictionary, pronounces the house his parents have just rented "The Amityville Horror." Tate's parents' marriage is breaking up and his father, Billy (Shane West) moves out shortly thereafter.

Next door neighbor Gossamer (Alexendra Grey) is a Black, transgendered, 25-year-old woman, who lives with her retired English teacher, father Edward (Franklin Ojeda Smith). Edward still calls Gossamer "George." Gossamer feels stifled in Kansas City, and dreams of moving to New York.


Gossamer works hard to earn Tate's confidence. Although Tate's parents do not approve of Gossamer and want their son to avoid her, Gossa-

Contest Showcases Young Illinois Artists: Illinois children can showcase their artistic talents and consider the importance of art in our lives, thanks to a statewide art contest sponsored by the Abraham Lincoln Presidential Library and Museum and the Illinois State Board of Education.

# Proposed House Rules Add Speaker Term Limits, Remote Committee Meetings

House Rules Committee meets Wednesday to vote on proposal

When Emanuel "Chris" Welch was elected House Speaker last month, he stated his intention to revise the rules that govern committees and the procedures for conducting business in the Illinois House of Representatives, including those pertaining to the introduction of new bills.

"We're being sincere in taking a quick, hard examination on these rules," Welch, D-Hillside, said in an interview with Capitol News Illinois this month, suggesting his willingness to amend the rules, unlike his predecessor, former Speaker Michael Madigan.

Proposed changes to the House rules, which were posted online Monday, will come before the Rules Committee for a vote when the committee convenes in the Capitol on Wednesday morning.

Capitol News Illinois compiled some of the significant amendments made to the House Rules below.

#### Leader term limits

Madigan earned the distinction as the longest serving House speaker in any state legislature in the country. Madigan's more than four decade-long tenure as speaker was due in part to the fact that the House rules did not place any limit on the number of terms a speaker could

serve.

Under the new proposed rules, no would member be allowed serve as speaker or leader of the minority party for more than five General Assemblies. Since each General Assembly spans a twoyear period, any future House Speaker or Minority Leader would be limited to a 10-year term.

The new proposed rules would allow for Madigan to serve another decade because the rules exclude a member's years of service as speaker that occurred before the current General Assembly. The term limits for speaker and minority leader can be lifted by a vote of 71 members.

#### Remote legislating

The proposed rules would allow for House committees or task forces to meet remotely by video technology, "in the case of pestilence or public danger." Remote committees are currently allowed in the Senate, but the House failed to pass a measure during the lame duck session in January that would have permitted it for substantive action in the full chamber

Under the new proposed rules, action taken by members remotely during committee or task force meetings will "have the same legal effect as if the member were physically present when the action is taken."

The technology used for remote meetings must be adequate to at least identify members who are participating, allow for the public — including the media — to hear and view each member and witness participating, and allow for witnesses to testify.

#### Special investigating committee

House rules permit members to create a "special investigative committee" that could lead to disciplinary actions against a House member who is the subject of the committee's investigation.

Most recently, Republicans launched a special committee investigation into Madigan after federal prosecutors revealed that utility giant Commonwealth Edison admitted its executives were bribing associates of Madigan in order to ensure legislation favorable to the company.

In that case, Minority Leader Jim Durkin, R-Western Springs, initiated the petition that created a special investigating committee against Madigan.

After the committee was formed, Madigan recused himself and allowed Rep. Greg Harris, D-Chicago, to select the Democratic members of the committee. Ultimately, Welch, who chaired the committee, and the two other Democrats on the committee voted to end the committee's work without disciplining Madigan.

The proposed rules would formalize the speaker's recusal from a special investigating committee if the speaker is the subject of the investigation, as Madigan was.

They require the speaker or minority leader — if that person is a petitioner or subject of the petition — to designate the highest ranking member of their caucus to perform the duties and powers of speaker or minority leader with respect to the special investigative committee.

Under the proposed rules, the chairperson of the special investigative committee can establish procedural rules as long as they don't conflict with the general House rules. Those procedural rules would then be filed with the House clerk and provided to each committee member and the petitioner.

mer and Tate become chums. A babysitting emergency forces Tate's Mother, Frannie (Sprague Grayden) to ask Edward and Gossamer to watch Tate while Frannie is at work.

The central theme of this film is the heart-warming friendship between Tate and Gossamer. Tate has no concept of Gossamer as anything but a woman and bears no stereotypes or prejudices. Everyone in the film has a personal struggle and together, Edward, Gossamer, Frannie and Tate all work through them.

#### We Left As Brothers

#### Rated PG-13, Directed by Evan Mulgrave

Fifty years later, six veterans return to Vietnam. Each had fought the war in a different place. As individuals, the group of returning veterans felt that they had not been able to talk about their experiences for years or even decades after their service. Each of them wanted to tell their stories and what it felt like to return to those spots fifty years later.

The veterans found a changed Vietnam, one that had moved on and did not harbor a malice to them or other Americans. In many cases, the returning Americans found Vietnamese who welcomed them to their country. Several of the people they met had wartime experiences or had learned of the war from the experience of family members.

This documentary shows how Vietnam has evolved into a modern nation and is an interesting epilogue for those of the Vietnam War Era. It also offers an interesting perspective and explanation for subsequent generations of the process of coming to grips with the Vietnam experience in an objective and reasoned way.

#### More Than Miyagi Rated PG-13, Directed by Kevin Derek

Actor Pat Morita had a diverse, interesting career, and this feature-length documentary does a great job of covering both the highs and the lows.

Morita had spinal tuberculosis as a child and was not expected to ever be able to walk. He spent much of his early life in hospitals and, when released, joined his family in a Japanese internment camp in Arizona. After the war, the family returned to the Bay Area. Morita worked several other jobs before trying stand-up comedy full time. He became acquainted with Red Foxx, who gave him a role in *Sanford and Son*, which ultimately led to playing Arnold, owner of Arnold's Diner in the television show *Happy Days*.

His most famous role was that of Mr. Miyagi, the patient karate teacher who taught Daniel (Ralph Macchio) to defend himself against bullies in the 1984 film *The Karate Kid*. Initially, producer Jerry Weintraub did not want to cast Morita, looking for a more "serious" actor. For his role in *The Karate Kid*, Morita was nominated for an Oscar as Best Supporting Actor. Morita went on to make several more films in the Karate Kid franchise and had a long filmography of other television and motion picture credits.

More Than Miyagi tells an interesting story and describes Morita's personal struggles as well as his successes. Beyond the many film excerpts, more than a dozen actors who worked with Morita contribute their perspective to the narrative. The film is well-paced, good storytelling, and is enjoyable to watch.

A special treat is the soundtrack. Many live performances in this film feature the same legendary Cuban musicians who appeared in the hit film *Buena Vista Social Club*.

Mambo Man has won numerous awards including Best Picture at the Ciudad de Mexico International Film Festival, Continental Film Festival, and Florence Film Awards; Best Original Song at the Hollywood Gold Awards; and Best Cinematography at the Anatolia Film Festival.

# Welch's Ascension Provides Golden Opportunity to Change House Rules for the Better

Very seldom does any one individual have the type of golden opportunity that recently elected Illinois House Speaker Chris Welch has been presented.

The story is stale now as to how the longest serving speaker in the history of the United States, Michael Madigan, lost his grip on the gavel here in Illinois. Madigan has been a member of the Illinois House since 1971, and for all but two years since 1983, the 78-year-old was speaker of the Illinois House. In 1995-96, Republican Lee Daniels managed to wrestle the gavel away.

It was during those two years of GOP control that the House adopted rules which provided the speaker with immeasurable power. In fact, House rules passed during the two years that Madigan was not speaker started the slide to what has become almost one-person rule. It was a slippery slope resulting in democracy being replaced with autocratic rule.

During the time I was a member of the Illinois House, I watched as these rules stymied attempts by legislators of both parties from moving proposals forward. Currently, House rules provide the speaker with the authority to assign a majority of committee seats to members of the majority party. Committee members then serve at the pleasure of

the speaker and can be removed or substituted at any time.

The most critical committee a legislator can be assigned to is the Rules Committee. When a bill is filed by a representative, the legislative proposal goes to the Rules Committee consideration. for This committee assigns either the proposal to another standing committee, or it remains in Rules Committee. There is no other real avenue for the bill to move forward. A representative can move to discharge a bill from Rules Committee. However, the vote for the discharge motion pass requires unanimous consent. That is a high hurdle since the speaker is also a House member and can simply vote "no." Amendments can be filed to each bill as the proposed legislation moves through the process. However, amendments are also initially assigned to the Rules Committee. Because the speaker assigns a majority of members to the Rules Committee, this allows for absolute control.

So far, Chris Welch has talked like someone who is open to changing some House rules. I hope so. All too often when all is said and done, there is more said than done. This opportunity is critical and too rare for mere lip service.

Changing the rule regarding discharging proposals from Rules Committee would be a good start. I am not suggesting that every bill should be sent to the House floor for consideration. There are thousands of bills filed every year and there is no way all of these proposals could be heard. However, a rule could be adopted allowing for any measure that has enough co-sponsors to be discharged to either the House floor or standing committee. If a majority of the House members (60) co-sponsored a bill, it would go to the House floor. The proposal would be released to a standing committee if a reasonable number of House members (40) co-sponsored the proposal.

How about a rule change that requires the final version of the Illinois budget to be on display for at least 72 hours? I was a school superintendent for 17 years and our local school district's budget was required to be on display for 30 days. Further, any proposal, in a final form should be held for at least 24 hours before a final vote. Amendments that are hundreds of pages long are filed on bills and dumped on the desk (laptop) of lawmakers to vote on without proper time to study the final version. Even worse is that citizens represented by the lawmaker do not have time to contact their elected officials to weigh in. Unintended consequences could be avoided if more time were taken to study final versions.

These are just two examples of potential changes. There are many more rule changes which would turn Illinois around and restore confidence in our state government. You might want to let Speaker Welch know your thoughts. Contact information is located at www.ilga.gov under House members. Let's not miss this golden opportunity.

# **Illinois House Adopts New Rules on Partisan Lines**

GOP lawmakers argue changes don't go far enough

The Illinois House adopted new rules on Wednesday that Democrats say are intended to make the legislative process more transparent, but Republicans argue they don't go far enough in reforming how the General Assembly operates.

The new rules represent one of the first attempts by newly-elected House Speaker Emanuel "Chris" Welch to break from the practices and traditions of his predecessor, former Speaker Michael Madigan. Madigan's opponents claimed he exercised vast authority to decide which bills would be assigned to committees, which ones would come to the floor for a vote, and which ones would not.

"These new house rules really do represent a historical turning point in rules development and adoption in the House of Representatives," House Majority Leader Greg Harris, D-Chicago, said while explaining the new rules.

Harris said the rules are also "just a first step in reforming ways of the past and injecting more transparency and accountability, while ensuring our chamber operates effectively and fairly."

One of the most significant changes from the Madigan era is a new rule that limits any individual to serving no more than five biennial sessions, or 10 years, in either the office of speaker or minority leader. Madigan served in that role for all but two years from 1983 until this January.

Another major change allows legislative committees to meet and take votes remotely "in the case of pestilence or public danger." The inability to meet virtually has been a handicap for the House since the start of the COVID-19 pandemic, which virtually shut down the 2020 regular session as well as the fall veto session.

House leaders have said they plan to limit most legislative activity to remote committee meetings at least through the end of February, and they don't plan on the full House coming back into session to vote on bills until sometime in March or April.

Other changes are more technical in nature, but still important to the legislative process, including rules that apply to the Rules Committee itself. That's a committee, usually made up of top legislative leaders, where all bills and resolutions go first and then get referred to other committees.

It has also been a committee where, in the opinion of some, good legislation would go to die because the committee had the option of sitting on bills and not referring them to any other committee, thus ensuring they would never receive a hearing or come up for a vote.

Under the new rules, in odd-numbered years, the Rules Committee will be required to refer all House bills it receives to a substantive committee before the deadline for committees to act on bills, as long as the bill was filed in a timely fashion. Exceptions exist if the principal sponsor asks for it to be held for some reason.

"Once again, the members of the 102nd General Assembly are making it clear that this does mark the end of business as usual," Rep. Lindsey LaPointe, D-Chicago, said during debate on the rules. "These new rules have been developed through a fair and transparent process that has brought in good ideas from both sides of

Republicans, however, argued that the change would make little difference because individual committee chairs could still stifle legislation, either by never calling a hearing on a bill or by referring it to a subcommittee, which would be under no obligation to ever meet.

They also argued that the rule applies only to bills and not to proposed constitutional

amendments such as the so-called "Fair Maps" amendment, which has support from members of both parties in its effort to overhaul the way Illinois redraws legislative and congressional district lines every 10 years.

Republicans had also pushed for other changes such as requiring public notices for which bills would be considered in committees or on the House floor each day, something that in many cases isn't decided until the last minute.

"We've had too many instances, the latest being in lame duck session, where significant bills were brought forward for debate at the 11th hour," Rep. Mark Batinick, R-Plainfield, said during debate. "As lawmakers we need adequate time to read bills in final form and time to determine our position on each issue like we did with these rules, which was really a nice process."

Harris responded to those criticisms by saying that members of both parties have used the rules in recent years to get around the normal posting requirements. But he also said Democrats would be willing to consider additional changes if the two sides can come to an agreement.

"I stand with the speaker in saying we look forward to working with you in the next several months on addressing some of these items, and if we all agree that there are some problems to fix and we come to a consensus, then let's fix them," Harris said.

# **Committee Questions IDES Director, Staff Over Unemployment** Handling

Fraud, delays among top issues addressed by Sarah Mansur Capitol News Illinois

Representatives of the Illinois Department of Employment Security on Wednesday testified before the Senate Labor Committee about fraudulent claims, continued delays in responding to unemployment applicants and a multibillion dollar deficit in the fund that pays out benefits.

Acting Illinois Department of Employment Security Director Kristin Richards and members of the department's staff fielded questions about the backlog that individuals face when they contact the agency with questions about their

While the agency has seen fewer traditional unemployment claims, it has continued to see individuals fileroughly 700,000 to 800,000 claims per month since August through the pandemic unemployment programs created through the federal Coronavirus Aid, Relief, and Economic Security Act and other federal programs. Those include the Pandemic Unemployment Assistance program, the Pandemic Emergency Unemployment Compensation program, and the Extended Benefits program

IDES has put in place a callback system to reduce wait times for callers and a web form online for people to submit questions, but Richards said individuals still wait between one to two weeks for a callback from the agency, depending on the subject of the call.

"But I need to stress that if an individual has, for example, reached out to us about the status of their adjudication or appeal it could take four to six weeks because it's working its way through the process and we need to connect with the right professional to help them. We realize that is less than ideal for individuals dying for an answer from IDES," she said.

Richards said IDES is working to address those delays by training contractual staff members and adding full-time employees to the agency. The agency has roughly 1,200 employees, Richards said, including about 750 contractual staff.

She said the agency has stopped slightly more than 1 million identity theft claims, including through the traditional unemployment system and the PUA system, but the agency doesn't know the specific amount of money that has been paid out in fraudulent claims.

Some of the new unemployment programs created during the pandemic, especially the PUA program, left unemployment systems vulnerable, Richards said.

"That new program had no employer wage base to balance off of. There was no second step, as a check and balance. Until wage verification documents were required, we saw that imposters were getting in," she said.

#### Overpayment of benefits

Richards also announced during the virtual committee meeting that the department will begin to send out waivers next week to individuals who had received an overpayment of benefits under the Pandemic Unemployment Assistance, a federally funded program providing unemployment benefits to gig workers and others not traditionally eligible for them.

By law, claimants who were overpaid benefits must repay the money they were not due under unemployment laws. The waiver authority provided in federal law allows the state to waive the repayment in certain circumstances if the overpayment was not the fault of the claimant.

The overpayment waivers are available through the federal Continued Assistance for Unemployed Workers Act, or CAA, which was signed into law in December.

"If the waiver request is successful, we need to return those dollars that were recuperated to the claimant," she said, adding the department has not yet developed a mechanism to return the money.

She said the agency is working on creating a questionnaire and request form for those eligible for a waiver, and the agency would consider those requests on a case-by-case basis.

IDES Manager of Unemployment Insurance Programs Justin Brissette said overpayment is not uncommon, but the number of new claims has made it more prevalent.

Richards said one of the issues that resulted in some overpayments was individuals inadvertently providing wrong wage information, such as listing their net income rather than gross income.

#### **Trust Fund**

The committee also discussed the deficit in the Illinois Unemployment Insurance Trust Fund — which funds unemployment payments – and is projected to have a negative balance possibly exceeding \$8 billion in the next two years, according to a presentation from the department.

Sen. Jason Barickman, R-Bloomington, raised questions about the impact of fraudulent claims on the trust fund's deficit.

"We all will have to work on a solution to the trust fund. I think everyone recognizes that," Barickman said. "There was a tremendous presentation today on the amount of fraud that exists. There was a tremendous presentation on the negative balance that is going to exist in the trust fund and I have no data in front of me on how to tie those two together. Shouldn't we have that data, as lawmakers, so that we can understand what the financial impact has been on our trust fund?"

In response, Richards said she did not have that information but would work on getting it to lawmakers. Pressed further, Richards said she couldn't provide a timeframe on when that information would be provided.

"I hear you loud and clear," she said. "We need to come up with the numbers and provide that to the committee."
