### Origins Of Juneteenth Date To Civil War

Celebration Traced to Freeing of Slaves in Texas in 1865

Juneteenth, which is coming up June 19, is the newest federal holiday in the calendar. Its origins, however, date to the final weeks of the Civil War.

The commemoration arose from the freeing of slaves in Texas on June 19, 1865, eleven weeks after the surrender of Robert E. Lee at Appomattox and the assassination of President Abraham Lincoln.

The act helped fulfill the promise of the Emancipation Proclamation, issued by Lincoln on Sept. 22, 1862. The proclamation took effect on Jan. 1, 1863, and many Americans today believe that all enslaved people were freed.

But that was hardly the case. The proclamation only applied to states in rebellion, meaning that slavery continued in the border states of Missouri, Kentucky, Maryland, and Delaware.

Lincoln's proclamation also had to be enforced. While large parts of the South were under Federal control by 1863, Texas, the westernmost member of the Confederacy, was largely untouched. Relatively few military actions were conducted in Texas, and few Union soldiers occupied the state.

As a result, slavery continued with little threat in Texas. Planters from elsewhere in the South migrated to the Lone Star State during the war, to keep their slaves from confiscation and freedom.

Kathryn Harris, the retired Director of Library Services at the Abraham Lincoln Presidential Library and Museum in Springfield, notes the lapse in emancipation for many slaves in the South.

"On the eve of the Emancipation Proclamation, there had been 'Watch Night' celebrations for many blacks, with the coming of freedom," remarked Harris, a respected authority on African-American history. "But it took a while for that freedom to come to much of the nation, especially Texas."


By 1865, some 250,000 blacks remained enslaved in Texas, even as the end of the war was imminent. Finally, Maj. Gen. Gordon Granger arrived at Galveston on June 19, 1865 to assume command of a Union force of 2,000 troops.

That same day, Granger read General Order No. 3, declaring that, "in accordance with a proclamation from the Executive of the United States, all slaves are free" with "an absolute equality of personal rights and rights of property between former masters and slaves."


General Order No. 3 was read at several locations throughout Galveston, an emotional series of events for the slaves of the city and the state.

"I can only imagine their excitement of being free," said Harris. "However, that must have brought a wide range of feelings. If you've never been free, as those people had not, you don't quite know what to do. It was a completely new experience, an overwhelming one."

Maj. Gen. Gordon Granger


# Regulations in AI and 465 Other Bills Passed This Session

Bill allowing digital driver's licenses also clears General Assembly

Abill banning what unions refer to as employersponsored "captive audience" meetings about religion and politics has cleared both chambers of the General Assembly.

It was one of 466 measures to do so during the Illinois legislature's recently concluded spring session, including measures targeting artificial intelligence and allowing for digital driver's licenses. A Capitol News Illinois analysis shows 287 of the bills passed in the session's final two weeks.

If the "captive audience" bill is signed by the governor, employers would still be allowed to discuss religion and politics with employees, but workers would have the right to skip the meeting, whether on or off the clock, without retaliation.

The Illinois AFL-CIO labor organization brought the legislation to state Sen. Robert Peters, D-Chicago, and celebrated its passage as a win for workers. In a news release, Illinois AFL-CIO President Tim Drea said the meetings "are a direct violation of workers' rights."

The meetings were made legal in 1947 under what's known as the Taft-Hartley Act. But labor advocates across the country, including other state chapters of the AFL-CIO and the current National Labor Review Board General Counsel, Jennifer Abruzzo, are working to definitively outlaw mandatory attendance at meetings where anti-union rhetoric is shared.

### Health Insurance Changes Targeting Steering and Denial of Service - More Heading to Governor

Pritzker first announced the initiative during his budget address

A package of health insurance reform measures that Gov. JB Pritzker called for at the beginning of the legislative session will soon be headed to his desk for his signature.

The Illinois House gave final approval Saturday to a pair of bills that limit the ability of insurance companies to deny coverage or steer individuals toward lower cost, and sometimes less effective, treatments and medications, strategies sometimes referred to as "utilization management."

The package also includes measures giving the Illinois Department of Insurance authority to approve or deny premium rate changes in large-group health insurance plans while banning the sale of short-term, limited duration individual health plans, which are sometimes derisively referred to as "junk insurance."

In a statement issued moments after the House vote, Pritzker called it "a historic win."

"When I first proposed this legislation in my FY25 Budget Address, I said we would put power

back into the hands of patients and their doctors and reform predatory insurance companies and their unfair practices," he said. "That's exactly what we did."

Pritzker first called for the changes in his State of the State address in February, saying they would "save lives and lower healthcare costs for millions of Illinoisans."

The biggest changes are included in House Bill 5395, dubbed the "Health Care Protection Act." Among other things, it requires insurance companies to use "generally accepted standards of care" when deciding whether to cover certain treatments or services.

It also bans the use of step therapy requirements in prescription drug plans that require a patient to show that a lower-cost alternative drug is ineffective before covering a more expensive drug recommended by their physician.

The bill also prohibits insurance plans from requiring prior authorization before covering inpatient psychiatric care. For other kinds of care, it requires insurers to post publicly on their website when prior authorization is required.

It also requires insurers to maintain accurate, upto-date lists of providers who are included in their networks

And it gives the Illinois Department of Insurance authority to approve or reject proposed premium rate changes in large-group health insurance plans, similar to the authority it already has over small-group plans.

Another provision which the Senate put into a separate bill, House Bill 2499, would prohibit the sale of one type of insurance known as "short-term, limited duration" health policies – sometimes derisively referred to as "junk insurance" – that do not have to meet minimum standards under the federal Affordable Care Act.

Those changes apply only to the types of insurance plans regulated by the state. Those include employer-based group plans that are fully funded by the insurance carrier as well as plans offered by local governments and plans provided under the state Medicaid program. They do not apply to plans regulated under the federal law known as ERISA – the Employee Retirement Income Security Act of 1974.

The package originally passed the House as a single bill in April with bipartisan support, 81-13. Pritzker spent the next several days touring the state to drum up public support, making appearances with doctors and patients at health care facilities in Belleville, Peoria, Rockford, and other cities.

Meanwhile, talks continued behind the scenes between advocates for the changes and the Illinois Life & Health Insurance Council, the insurance industry's main lobby group. Over the next several weeks, those talks led to compromise language on the use of step therapy and prescription drug formularies, as well as Department of Insurance review of large-group rate changes.

"I appreciate having a seat at the table throughout this legislative process and thank the governor for hearing our concerns and engaging us as a partner," ILHIC president Laura Minzer said in a statement Saturday. "While we may not find agreement on every provision, being heard, and listened to, is integral to finding the best solutions for this meaningful legislation. It is with this spirit of cooperation

that the council will continue working to make improvements during the legislation's implementation phase."

Talks in the Senate also led to the decision to separate the package into two bills, splitting off the more contentious

proposal to ban the sale of short-term limited duration policies into separate legislation.

Those policies are typically sold to people who are temporarily unemployed or have some other circumstance in their life that causes them to need coverage for only a short period. But while they often cost less than traditional policies, many of them also have high deductibles and do not offer the same types of benefits that are mandated in other plans, such as coverage for emergency treatment, laboratory services or preexisting conditions.

"I have had people reach out to me who thought they had coverage when they had these short-term limited duration plans, only to find out that they were not covered," Sen. Laura Fine, D-Glenview, said during Senate debate Thursday. "Their prescription drugs were not covered. Their emergency services were not covered. And it ended up costing them a whole lot more than it would have, had they had the insurance that they thought was possible and that they thought that they were paying for."

Republicans, however, argued that for many people, short-term limited duration plans are a more affordable alternative than continuing an employer-based policy through a COBRA plan or buying an individual plan on the Affordable Care Act exchange market. They argued consumers should be allowed to choose the option that is best for them.

Sen. Win Stoller, R-East Peoria, compared shortterm policies to mobile homes, which may be built of inferior materials compared to a traditional home, but which are still suitable for some people.

"And I would never be so audacious to suggest that we should ban mobile homes. I think that's absurd," he said. "But that's exactly what we're doing here in relation to these short-term health plans, saying that we know better than you, we know what's best for you. We don't think you can make an informed decision."

The stand-alone bill, HB 2499, passed the Senate on a straight party-line vote, 40-19. The remainder of the package contained in HB 5395 passed with a handful of Republican votes, 45-14.

Likewise, the vote in the House to concur with the Senate changes to the ban on short-term limited duration policies fell along party lines, 72-35. The concurrence vote on the remainder of the package passed with a handful of Republican votes, 83-23.

### **Lawmakers OK Bill** To Require 'Faithful' Electors in 2024, Loosen **Campaign Finance Rules**

Legislative package also reforms voter list access, some local officials' salaries

As the 2024 presidential election approaches, Illinois appears likely to join most of the rest of the country in requiring that the state's Electoral College votes go to the winner of the state's popular election.

The measure is part of a broad package of electionrelated legislation which also includes a provision loosening restrictions on what political parties can do with campaign funds and a state-level response to a controversy in the south suburbs.

The entire package was approved 51-3 in the Senate, with three Senators voting present. The House was more divided, passing the measure 68-38. The bill now goes to Gov. JB Pritzker for final approval before becoming law.

In United States presidential elections, voters on Election Day cast a vote for president, but also for electors associated with a particular candidate. Legally, these electors are the ones who actually cast a deciding vote in the presidential election, usually in mid-December.

The bill would require the state's electors to take a new pledge prior to appearing on the ballot. Failing to honor the pledge under the proposal would result in them being removed from their position and replaced with an alternate elector.

These electors have been under increased scrutiny

in the past decade, due in large part to the 2016 election, which saw Donald Trump win the presidency despite losing the popular vote – the fourth such occurrence in U.S. history.

While Illinois has never had an elector vote for someone who didn't win the popular vote, other states have, including seven electors from three states in 2016.

The legislation concerning the Electoral College is based on model legislation that has been adopted in 12 other states, according to the Chicago-based

Uniform Law Commission, which published the model law in 2010.

"The purpose of it is to make sure the popular vote is protected by electors in the Electoral College," Rep. Daniel Didech, D-Buffalo Grove said Saturday in an interview.

Didech was not formally a sponsor of the package but is a delegate to the Uniform Law Commission and introduced the model bill as separate legislation

If the measure is signed, Illinois would join 33 other states with laws in place requiring electors to vote for the candidates that they pledged to support, according to a March analysis of state laws by the National Conference of State Legislatures.

After the 2020 election, while no electors cast "faithless" votes, the Electoral College again became the focus of controversy. Some allies of Donald Trump allegedly orchestrated a scheme to send a slate of electors outside of the legal process, thereby securing a second Trump term in 2020.

Eighteen people, including Trump lawyer Rudy Giuliani and former White House Chief of Staff Mark Meadows, were indicted in Arizona state court on charges related to the scheme in April of this year.

### Party campaign funds

The bill also removes a restriction on the way political parties handle primary campaigns. Under the proposal, candidates for state and federal office would be able to accept an unlimited amount of campaign cash from political parties.

Currently, candidates can receive unlimited support during a general election, but in primaries, parties are capped on contributing to individual

candidates. For example, prospective members of the House are limited to \$75,000, candidates for Senate and Supreme Court are limited to \$125,000, and statewide candidates are limited to \$200,000.

"What we have now from another came era," bill sponsor West, Rep. Maurice D-Rockford, said during floor debate on Saturday. "We do not see the need for that cap any longer."

This provision was pushback with from Republicans, who pointed to former House Speaker Michael Madigan, who awaiting trial on bribery

and racketeering charges. He was known for his use of the Democratic Party of Illinois' campaign war chest as a lever to exert control over his caucus.

"The former leader of your Democrat Party, that you want to give all this control, is on the brink of going to prison, we hope. He should," Rep. Blaine Wilhour, R-Beecher City, said. "Why in the world would we be making these organizations more powerful than they already are? Were they not powerful enough before?"

The primary cap was initially codified in 2009 as part of a sweeping reform campaign championed by then-Gov. Pat Quinn. Quinn signed the law less than Continued on page 5

Still, not all blacks were emancipated. In some cases in Texas, owners did not inform their slaves until after the harvest, months after Granger's declaration. Slavery throughout the United States was finally banned with the ratification of the Thirteenth Amendment on Dec. 6, 1865.

On the first anniversary of the Galveston declaration, free blacks in Texas organized a celebration dubbed "Jubilee Day." The earliest commemorations were often political rallies, to inform blacks of newly-gained voting rights.

Jubilee Day evolved into Juneteenth festivities, though there is debate as to how the name of the holiday originated. Many believe the name is a combination of the month and day, June 19. Others theorize that the words "Jubilee Day" somehow morphed into "Juneteenth."

Texas was the center of Juneteenth celebrations for decades. In 1867, the first event was held in Austin, and became an annual event in 1872. That same year, African-American organizers and clergy raised \$1,000 to buy ten acres in Houston, christened "Emancipation Park," for Juneteenth celebrations.

Many of the early Juneteenth festivities drew huge crowds. In Limestone County near Waco, thirty acres were purchased in 1898 to create Booker T. Washington Park, designed especially for Juneteenth festivals. As many as 30,000 attended the commemorations there.

In the early-to-mid-20th century, the holiday continued in pockets as blacks from Texas emigrated across the nation, taking Juneteenth with them.

However, the onset of Jim Crow laws, particularly in the South, slowed the growth of Juneteenth.

"Blacks in that time were still struggling for so many things," commented Harris. "Then, when Jim Crow popped up, along with the problems of Reconstruction, that added so many problems. And once the military was removed from the South to protect the freedmen after Reconstruction, that was really horrible.

"I think, more than anything else, that Juneteenth represented hope," continued Harris. "Even though freedom had come, many blacks still weren't really free. I think the holiday represented the hope of a better tomorrow."

The Depression added to the struggles, as blacks scrapped to find work and survive, pushing Juneteenth further to the background. But the commemorations persisted, at least in some spots. The Texas State Fair became the focus of many Juneteenth remembrances, particularly in 1936, when some 150,000 to 200,000 were present.

As more blacks left Texas in the post-war era, Juneteenth continued to spread, though the holiday languished throughout much of America. Some historians, however, attribute a rebirth to the assassination of Martin Luther King, Jr. in

1968, which sparked more interest in the spirit of Juneteenth.

That year, the storied "Poor People's March" on Washington ended on June 19, and marchers invoked Juneteenth as they returned home. From that, large-scale celebrations arose in cities like Milwaukee and Minneapolis, which remain to this day.

A 1978 celebration in Milwaukee attracted over 100,000 participants. Four years earlier, substantial celebrations of Juneteenth returned to Houston. Elsewhere, other major cities began Juneteenth events in the 1980s. In 1991, an arm of the Smithsonian Institution hosted a major exhibit titled "Juneteenth '91: Freedom Revisited."

In 1980, Texas became the first to officially establish Juneteenth as a state holiday. Other states, though, were slow to follow, and by 2002, only three states had joined Texas in that designation.

By 2008, half of the states had established a ceremonial holiday, including Illinois, which formally recognized Juneteenth in 2003. In 2020, Juneteenth was recognized in all fifty states.

Over 200 American cities held commemorations of Juneteenth in 2006, including Springfield, where an annual event was created in the mid-1990s

On June 16, 2021, Illinois became the latest in a handful of states to establish Juneteenth as a paid state holiday. The next day, Juneteenth was established as a federal holiday, the first since the creation of Martin Luther King Day in 1983.

Critics have charged that the recent legislation for Juneteenth has been purely for political reasons. But Harris and many others believe the actions are long overdue, and that the holiday is not just for blacks.

"It really should have been done a long time ago," she remarked. "And Juneteenth is truly a day for everyone, not just African-Americans. We talk about diversity, equity, and inclusion today, but we're really still working on the stuff that was talked about with the Emancipation, the end of the Civil War, and Juneteenth itself.

"To me, Juneteenth is a time of reflection, a time to think about where we are, where we've been, and the work that's left," concluded Harris. "And just like in the early celebrations, it's a time of hope."

Citing the Colorado governor's recent veto of similar legislation in which he said he would sign a narrower and more neutral bill, Sen. Jason Plummer, R-Edwardsville, said during debate that the pending legislation, particularly who it would impact and how, is not well defined.

"Let's not play politics with unconstitutional legislation that's going to get thrown out in the court of law," Plummer said.

Of the six states that have introduced similar legislation, only two have ongoing lawsuits. One is in Minnesota, filed by business groups including the National Federation of Independent Business Inc., and another is in Colorado, which was partially dismissed in 2023.

Senate Bill 3649 advanced out of the Senate on partisan lines, 39-18, after clearing the House 79-30 with some Republican support. The final version was amended to specifically exclude certain groups – including 501(c)(4, 5 and 6) organizations – that participate in lobbying activities and generally exist for the purpose of advocacy.

The bill still needs to be signed by the governor to become law.

### **Artificial intelligence protections**

A bill that would outlaw the creation and sharing of child pornography made using artificial intelligence was one of several AI-focused measures to clear the General Assembly in its final days.

House Bill 4623, which was backed by Attorney General Kwame Raoul, would expand current child pornography laws to also cover AI-generated child pornography.

Backers of the bill said if AI-generated child pornography rapidly increases, law enforcement's ability to identify real cases would be more difficult.

The bill, which passed both chambers unanimously, would also ban the distribution of various AI-generated sexual images without consent.

House Bill 4875 would protect individuals from having their voice, image or likeness duplicated by AI for commercial purposes without their consent. The bill would allow recording artists and those they contract with to seek damages for nonconsensual use of their likeness.

The measure, as amended, cleared both chambers unanimously.

House Bill 4762, also passed by both chambers unanimously, would protect performers and other individuals from wrongful use of AI replicas. The bill would make contracts unenforceable if the performer would have performed in person, the use of the digital replica was not defined or detailed in the agreement, and if they were not

represented by a lawyer or labor union during the agreement.

### **Digital IDs**

The secretary of state's office would be able to issue digital identification such as driver's licenses, learner's permits or state IDs to Illinois residents under House Bill 4592, which passed both chambers unanimously.

The cards would be issued "in addition to, and not instead of" a physical ID, under the bill.

The measure has an effective date of Jan. 1, 2025, giving the secretary of state's office time to implement and test a new digital ID platform before it goes live.

Under the bill, agencies and private entities may choose if they want to accept electronic IDs in place of physical ones, but "upon request by law enforcement, a credential holder must provide the credential holder's physical credential."

A digital phone application that registers identification cards with the secretary of state's office would cost a maximum of \$6 under the bill heading to the governor's desk.

In 2021, the American Civil Liberties Union published a report warning of potential privacy risks that could come with digitizing government IDs. The bill addresses some concerns by barring law enforcement from requesting or searching through an individual's phone.

It also requires the secretary of state's office to "use an electronic credential system that is designed to maximize the privacy of the credential holder ... and shall not track or compile information without the credential holder's consent."

### Family obligation discrimination

House Bill 2161 bans workplace discrimination based on family responsibilities.

Senate sponsor Sen. Natalie Toro, D-Chicago, said the bill's goal is to "prohibit discrimination on an assumption that your family responsibility will impede your work performance."

For example, Toro said, a woman cannot currently be passed over for a promotion because of her family status if the promotion goes to a man with a similar status. But she could lose out on the promotion to another woman with no children.

Sen. Jil Tracy, R-Quincy, called the bill unnecessary, as the U.S. Supreme Court has interpreted federal Title VII – which prohibits gender and sex-based discrimination – to apply to cases regarding family obligations.

The bill passed the Senate 37-19 and the

### **Exoneree higher education benefits**

Senate Bill 3771 allows exonerated individuals to pass a state benefit covering higher education costs on to dependents. It passed the Senate 45-11 and the House 71-38.

Illinois leads the nation in exonerated individuals, with over 500 people having wrongful convictions overturned. Payouts to exonerees in Illinois remain some of the lowest in the country, but the Higher Education Student Assistance Act covers public university tuition and fees for exonerees.

The bill allows the state benefit to cover private, not-for-profit university costs so long as the total does not "exceed the maximum grant payable" towards a grantee in "the most expensive comparable" program at an Illinois public university.

If the recipient, either an exoneree or their dependent, maintains "satisfactory academic progress," grant funds can pay up to eight semesters or 12 quarters of full tuition and mandatory fees.

### Mold public health campaign

Senate Bill 1087 requires the Illinois Department of Public Health to create a public health awareness campaign informing the public about the dangers and importance of removing indoor mold. It also requires IDPH to establish "procedures for parties that provide mold remediation services to register with the state."

The bill passed out of both chambers without opposition.

a year after taking over the governorship from Rod Blagojevich, who was sent to prison for corruption related charges.

Reform for Illinois, an advocacy group known for backing ethics and campaign reform, condemned the move in a statement published Tuesday.

"It's a step backward that will increase legislative leaders' power over their members while supercharging the election money arms race and depriving constituents of the chance to be represented Press Foundation and the Robert R. McCormick by more independent candidates," Alisa Kaplan, the Foundation, along with major contributions from head of the organization, said.

### Voter rolls

The legislation also codifies that the public has access to the state's voter registration list. The database, which is required by federal law and routinely shared with local governments and political committees, is tightly protected by the Illinois State Board of Elections.

Prior to a 2020 lawsuit brought by the conservative Public Interest Legal Foundation, digital copies of the voter registration database were restricted to only government entities and registered political committees.

The bill codifies a court order from that lawsuit requiring the public have access to a redacted database - after paying a fee. Members of the public can also inspect the voter database for accuracy in-person at the Springfield board of elections office.

The bill also lays out what voter information cannot be used for: "any personal, private, or commercial purpose, including, but not limited to, the intimidation, threat, or deception of any person or the advertising, solicitation, sale, or marketing of products or services."

The voter rolls have been the subject of a recent controversy following their allegedly illegal publication on a series of websites that have been characterized as a conservative influence operation.

Those websites are published by Local Government Information Services, a company backed by one-time candidate for governor and longtime Republican activist Dan Proft.

LGIS' publication of the voter information initially included dates of birth. Earlier this month, Illinois Attorney General Kwame Raoul sued the company for publishing the data. After a court order requiring the company to take down the information, LGIS removed birth dates from their websites.

As of Wednesday morning, voters' names and street addresses were still accessible on several of its websites.

Illinois State Board of Elections spokesperson Matt Dietrich told Capitol News Illinois that the voter database provision of the law was written, in part, as a response to the LGIS lawsuit.

### Springfield's response to 'super mayor'

Another piece would require that the compensation for township supervisors in Cook County may not be increased during a term. An outgoing supervisor would also be prohibited from lowering the salary for their successor without lowering their own salary.

The bill echoes a situation in Chicago's south suburbs centered on Dolton Mayor and Thornton Township Supervisor Tiffany Henyard, who styles herself as a "super mayor" on social media.

Late last year, Henyard proposed a measure that would decrease the salary of Thornton Township supervisor from \$224,000 to \$25,000, but only for non-incumbents, meaning her salary would remain unchanged, even if she was reelected, according to reporting from Fox32.

While West didn't mention Henyard specifically, he suggested that the measure was in response to a real-world situation that he described as "a way of being spiteful."

Henyard has also faced criticism for using taxpayer funds for billboards promoting herself and was sued by a local bar which claimed she denied the business a permit because it didn't contribute to her election campaign.



### **Controlling Mosquitoes** On Your Property

Press Release

Mosquitoes are already out in force this season. How can we protect ourselves and our families and still enjoy the outdoors?

"Humans are mosquito magnets," says University of Illinois Extension educator Chris Enroth. "Not only are forgotten plastic kiddie pools in the backyard good for mosquito breeding, we also attract mosquitoes simply by being living, breathing mammals."

### **Personal protection**

What makes one person more attractive to mosquitoes than others? Enroth says mosquitoes can't resist the following:

- Carbon dioxide: "Yes, every time you exhale, you draw those pesky little blood-suckers closer," Enroth says.
- Lactic acid: Humans produce lactic acid on our skin. Some produce more than others.
  - High skin temperature
  - Colognes and perfumes
  - Dark-colored clothing
- Warm days with low winds. "Mosquitoes are pretty lousy fliers, so cool days with high winds (over 10 mph) reduce their activity. Placing a fan facing an outdoor seating area will keep them at bay," Enroth says.
- Studies have also indicated that some people are just more desirable than others. Due to the complexity of factors that can play into this, researchers are unsure why exactly this is.

The Illinois Department of Public Health recommends DEET as the most effective chemical to use to combat mosquitoes. Look for sprays with DEET at 40% or higher for an effective, longlasting repellants Be sure to re-apply every 4-6 hours. DEET confuses the mosquito and blocks the females' ability to detect carbon dioxide, heat, moisture, and human sweat.

Avoidance is only part of the strategy. Controlling mosquito populations though habitat reduction and backyard treatments is another strategy to minimize bites.

### **Breeding sites**

"Only female mosquitoes bite," Enroth says. This is because they need a blood meal (protein) for reproduction. Once she has fed, the female will search out a favorable site to lay her eggs. Anything that holds stagnant water is her target. Preventing her offspring from developing into adult mosquitoes is the most effective control. Enroth suggests the following strategies to eliminate breeding sites:

• Remove any object on your property that may

hold water. For example, tin cans, toys, flowerpot saucers, stagnant pools, and the notorious old tire in the backyard.

- Change water in birdbaths weekly
- Stock garden ponds with top-feeding minnows
- Make sure covers are tight and free of holes over grills, cisterns, rain barrels, or anywhere water is stored
- Clean your gutters. This is often the unseen area for mosquito development. Enroth recommends cleaning out gutters in the fall and
- If you can't remove the standing water, Enroth recommends treating it with Bti (Bacillus thuringiensis israelensis). Bti only targets the larva of mosquitoes and a few species of fly.

Controlling adult mosquitoes

- "Avoid using bug zappers to control flying adults," Enroth says. "About 90% of insects killed with bug zappers are not mosquitoes. In fact several are beneficial insects like the brown lacewing."
- Mosquito foggers work for only a short period of time and are well-suited to being used prior to an outdoor event.
- Community-wide control programs work best. "Everyone has a role to play in minimizing mosquito population," Enroth says.

To prevent getting bitten by female mosquitoes and to minimize the spread of West Nile Virus. Illinoisans should follow the recommendations above for reducing habitat and personal protection.
