A World in Transition from the Ancient Ways to a Constantly Changing World

Coming toward us is an Eldredge Runabout. The Boone County History Museum and a mural depiction of the Eldredge Runabout, located near the scene of this photograph, have memorialized this early automobile in American history.


The photograph was shot in Downtown Belvidere, perhaps at Locust Street, looking from South State Street to North State Street sometime just after the dawning of the new century in what appears to have been the dead days of summer. We can establish the date by noting the horse-drawn wagon on the right side of the street, the automobile on the left, and the streetcar further down State Street going toward the Kishwaukee River. The telephone and electrical wires had long been strung back in the 1880s. The photograph marks the dawning of a new day and the passing of an old way. The street was still dirt, but soon would be paved.

Illinois lawmakers are growing concerned with the use of artificial intelligence in health care.

# **Legislation Clears Senate Committee**

Advocates say bans are shown to improve school climate

Legislation that would prohibit public school students from using cell phones and other wireless communication devices during class time cleared a Senate committee Tuesday and could soon be considered by the full Senate.

It's a policy change that Gov. JB Pritzker called for in his State of the State address in February and one that has been gaining popularity in recent years throughout the United States.

According to the health policy website KFF. org, at least nine other states have adopted statewide policies limiting or banning the use of cell phones in schools. Elsewhere, even in the absence of a statewide policy, individual districts have begun acting on their own, including Peoria Public Schools, which implemented its own ban this year. "This policy has proven effective in reducing distractions, enhancing student focus and better fostering social interaction," Peoria Superintendent Sharon Desmoulin-Kherat told the committee. "Our data indicates it has also contributed to reducing reduction in bullying and physical fighting, thus creating a safer environment for students."

temporarily shut down Illinois casinos, video gambling terminals, horse racing and professional sports — just days after legal sports betting went live — the state's gambling industry has seen an explosion in growth.

Even the state lottery, which was launched 50 years ago, has experienced an expansion in recent years after a decade of stagnation. Total state tax revenues from all sources of wagering in Illinois, including the lottery, surpassed \$2 billion in the last fiscal year.

Against this backdrop, some lawmakers are pushing for Illinois to join eight other states that have legalized internet gambling, also known as iGaming. It's a tempting possibility in a year when the state is facing a possible budget deficit and uncertainty about normally solid sources of federal funding as President Donald Trump and congressional Republicans are cheering for cuts.





One of Morgan's sponsored bills — House Bill 1806, which deals with the use of AI in online mental health services — passed unanimously out of the House Health Care Licensing Committee on Wednesday.

If enacted, the measure would prohibit licensed mental health professionals from using AI to assist in providing support in therapy or psychotherapy sessions.

Morgan said the National Association of Social Workers has received an increasing number of reports from users of these online services, who say they were not aware they were interacting with AI chat-bots during their sessions.

"The introduction of AI into mental health care presents, I think, pretty obvious but certainly serious risks that can lead to dangerous, even life-threatening consequences," he said in the committee hearing. "Again, it's probably obvious the most that AI does not have the ability to exercise ethical judgment or recognize when a person is in crisis, or adapt responses based on nonverbal cues and emotional tone — all the things that we're training our health care professionals to identify."

Morgan's other AI-related bill, House Bill 35, would change the way health insurance providers use AI to make decisions about customers' coverage. The bill passed out of the House Insurance Committee on an 11-6 vote on Tuesday.

Morgan outlined the bill's goal as "preventing inappropriate adverse determinations" from being taken against consumers. If HB35 is enacted into law, health insurers would be prohibited from solely relying on AI to deny, reduce or terminate coverage for patients. Instead, those AImade decisions would have to be "meaningfully reviewed" by a human employee who has the authority to override it.

Morgan said that every major health insurance provider currently is using AI in some way, both helpful and harmful to customers. Providers' use of AI to make coverage decisions for consumers without any oversight by real people is one of those harmful ways, he said.

"As we sit here today, insurance providers are using AI to decide what is going to be our health insurance claims," he said in the committee meeting. "We are completely blind to what that could be and how this be used against us and against our claims." Late last year, ProPublica published an investigation on EviCore, a company that's used by a large number of major insurance companies in the United States, which found that the AI algorithm EviCore uses to make decisions about consumer's coverage has high denial rates. "We have already seen large, nationwide insurance providers face class action lawsuits for relying on AI algorithms to deny life-saving care," Morgan said in the email to CNI, making reference to the lawsuits against Cigna, Humana and UnitedHealth Group, filed in recent years for their use of AI-driven decisions.

leafed in full, and men wearing straw hats instead of beaver. Women were wearing white dresses. Today few, if any, women wear dresses as was the custom a century or more ago, when women would not be seen in anything but a dress. Many women today will only wear a dress when they attend church, a wedding, or a funeral. Oddly enough, each of those activities has a direct connection to a church. However, almost any costume can be seen today in churches, depending upon the faith and the vision of the pastoral leader.

A stream of people originating from the National Sewing Machine Company is heading south. In all likelihood, they are leaving work for the day. Who were the men in the flashy new automobile driving south through Downtown Belvidere? The site of the runabout amongst the citizens may have been commonplace for people living in Belvidere, as the automobile was created and built here. The National built automobiles for other brands before creating the Eldredge. Perhaps it was a test drive of one just completed. It was a time when an automobile was a rare site in the country, but not in Belvidere. Belvidere was the scene of automobile development, and the sky was the limit for Belvidere's future in the industry.

Belvidere's mentality about economics was much different than today's post-proprietorship economy. The National was, by-and-large, a locally owned business. It was a wage labor economy, but it had roots here. Every other business in Belvidere was locally owned then and reflected the pre-industrial free labor economy where most people just worked for themselves, particularly in the rural subsistence economy where everyone was more or less "off the grid."

Even politics on the local level was based on the individual and not the party. It goes without saying that things are very different today. Boone County was then someplace between the frontier and a community in its development.

It was a time of transition in Belvidere and the nation. In that moment, the frontier had closed and the feeling of moving to the Western Frontier to reinvent oneself to prosper or otherwise was over. Americans began to move less, and technology was creating a life experience far different than that which had existed before.

Belvidere had developed both permanence and relevance. In the 19th Century approximately 25 percent of those living in Belvidere moved every year. Many just moved on, and Belvidere was just a moment in their pursuit of the American Dream. Belvidere gradually became a community where transportation and communication created opportunities for the individual to own a business and plant roots. Creative energies were what had built permanence into the settlements in the post-Civil War years. What they accomplished is what we see when we think of Belvidere. The train's arrival in 1852 was the catalyst for the frontier settlement to become a mercantile and industrial center, which had tentacles reaching nationwide.

Dare we ask the question? Does Belvidere have any control over its future today as it did then? If so, what would it look like when you close your eyes?

State Rep. Edgar Gonzalez, D-Chicago, asked a panel of his fellow House members this week to imagine Illinois facing another financial downturn like the pandemic-recession of 2020 when Trump was finishing out his first term. That year, Illinois faced a major budget shortfall, though federal stimulus money ended up helping the state recover.

"If we had something like iGaming, we would have still had a financial fallback in spite of gross negligence by the first Trump administration," he said Wednesday at a Capitol hearing on his proposal to legalize internet gambling. "Illinois is gambling with its financial future by delaying the adoption of iGaming."

Proponents of Gonzalez's House Bill 3080 point out that plenty of Illinoisans are already gambling on the internet illegally, often facilitated by overseas-based websites.

"Whether or not you choose to pass legislation legalizing iGaming, it is already here," James Hartmann, a lobbyist for sports betting giant FanDuel, told the panel. "Right now, you can take out your phone and in five minutes, be gambling real money slot machines from the app store, unregulated and untaxed."

Hartmann, who was heavily involved in drafting and negotiating Illinois' legalized sports betting framework as a House Democratic staff attorney in 2019, said iGaming sites are "flooding the Illinois market" - and operating unscrupulously.

Meanwhile, FanDuel, Draft Kings and other sports betting platforms must adhere to the law's strict requirements for age checks, problem gambling prevention notifications and other consumer protections to maintain their expensive licenses.

"And so while these bad actors profit, none of it is being captured in tax revenue for the state of Illinois," Hartmann said.

He and others pushing the iGaming bill claim Illinois could collect an additional \$1 billion annually in taxes on internet gambling. The estimate is extrapolated from a 2024 report commissioned by the Sports Betting Alliance, an industry group that represents the four biggest sportsbooks in the U.S.

Those mobile sports betting platforms, which operate in 31 states, Puerto Rico and Washington, the bars and restaurants in which those VGTs have proliferated in the 13 years since video gambling's launch in Illinois - warn the introduction of iGaming would prove a zero-sum game.

Indeed, the General Assembly's fiscal forecasting arm has for years reported on the cannibalization effects that new gambling opportunities have on existing gambling outlets. In its annual study from October, the legislature's Commission on Government Forecasting and Accountability continued to chronicle the downfall of Illinois' once-thriving horse racing industry, in addition to noting flagging revenues from the state's legacy riverboat casinos, the oldest of which have been in business for a little more than three decades.

While overall casino revenue in Illinois is up, that success is mainly attributable to the opening of six new casinos provided for under Illinois' massive 2019 gambling expansion law. Additionally, Rivers Casino in Des Plaines, Illinois' first land-based casino that opened in 2011, has also seen continued growth.

But the state's nine legacy riverboat casinos have seen their revenues decline "for nine consecutive years," according to the report. Visits to casinos in East St. Louis, East Peoria and Joliet's Harrah's Casino have seen significant drop-off. Many of those casinos would be even worse off if it weren't for sportsbook partnerships entered into during the thick of the pandemic, when the type of in-person betting that was provided for under the law was not allowed.

The Illinois Gaming Board opposes the bill due to the agency's own struggles to keep up with its existing regulatory responsibilities and the General Assembly's lack of motion on banning so-called "sweepstakes machines," which are similar to video gambling terminals but operate in a legal gray area.

Jay Keller, a contract lobbyist for Penn Entertainment Inc., noted the company has spent \$600 million in recent years enhancing and expanding its casinos in Aurora, Joliet and Alton — an investment "made with the understanding that Illinois' gaming landscape would remain stable," he told lawmakers.

"The economic impact of iGaming is uncertain, but the potential negative consequences are clear: The proliferation of online gaming could reduce in-person casino traffic, threatening jobs, lowering the economic benefits to local communities and ultimately discouraging future investments in the state," he said.

A study published last month, commissioned by the National Association Against iGaming, warned that if Illinois legalizes internet gambling, the state could lose \$252.5 million in direct casino tax revenues and 4,733 jobs, taking into account the gambling industry's adjacent hospitality industry.

Though the study concluded that land-based casinos underperformed expected growth in states where iGaming has been legalized, internet gambling proponents disagree.

"iGaming brings new customers to casinos," Sports Betting Alliance President Jeremy Kudon told lawmakers, saying the threat of cannibalization has become a mythical "Loch Ness Monster."

Another report the Sports Betting Alliance commissioned last year found that of Illinois survey respondents who participated in either illegal iGaming or placed online bets while traveling to a state where it's legal, 23% said they visited casinos more after they began iGaming. However, 54% said the frequency of their casino visits stayed the same, while 19% said they didn't go as much.

Additionally, Michael Pollock of the New Jersey-based consultancy firm Spectrum Gaming Group said "two immutable laws of human nature" will still attract people to casinos.

"One is that people like games of chance, and two is that people enjoy being in social settings," he said.

Trevor Hayes, an executive with Caesars Sportsbook, which operates in partnership with Elgin's Grand Victoria Casino, agreed, saying his company has found iGaming is "actually a marketing tool" for brick-and-mortar casinos to "find new customers – younger customers."

But that's exactly what some opponents worry will happen, creating a new class of problem gamblers.

A Tulchin Research survey published this week of 800 Illinois voters last month found 71% believed online gambling is more addictive than betting at casinos or other brick-and-mortar establishments. Seventy-seven percent of survey respondents agreed with the sentiment that "lawmakers should look for better ways to balance the state budget than expanding mobile gambling in Illinois."

The October report from the legislature's economic forecasting commission estimated that in the last five fiscal years, the per-capita amount spent on gambling and lottery tickets in Illinois has increased from \$325 to \$560 annually, driven primarily by the explosion of video gambling terminals in Illinois and sports betting.

Illinois' sports betting market is now second Penn also operates video gambling terminals in the nation behind New York in terms of

D.C., are eager to expand their nascent iGaming business into more states. The Sports Betting Alliance has been running geotargeted social media ads urging iGaming legalization in recent weeks, not just in Illinois but also Maryland.

The analysis from the gambling industry consultancy firm Eilers & Krejcik estimated \$775 million in state tax revenues after five years of legalized iGaming at a nearly 25% tax rate. The \$1 billion figure would reflect a higher tax rate more in line with what larger casinos and sports books pay, especially after a hike in the state's sports betting tax last year. Pritzker last month also floated a tax hike on casino table games to help fill the state's budget gap.

But opponents of legalizing iGaming including some casinos, video gambling terminal operators and the hospitality groups that represent throughout Illinois and sportsbooks at all three of its casinos, including mobile sports betting via the casino in Aurora. Keller noted that roughly half of Illinois casinos are on Penn's side opposing iGaming, while the other half are in favor of legalizing it.

Though one major labor union, the Chicagobased International Brotherhood of Electrical Workers Local 134, supports legalizing iGaming, another influential union is opposed.

Marc Poulos, the executive director of the labor-management group for the International Union of Operating Engineers Local 150, warned against any move that might jeopardize funding for state infrastructure projects, which provide jobs for Local 150 members.

"Every study that we have looked at shows that iGaming would cannibalize existing gaming positions, mainly video gaming terminals," he told the panel.

Ivan Fernandez, director of the Illinois Gaming Machine Operators Association, which represents the VGT industry, warned that, unlike video gambling and casinos, iGaming presents a more dangerous risk of addiction. He urged lawmakers to follow other states that have rejected bids for iGaming legalization in recent years.

"They declined to authorize putting online casino gambling at people's fingertips on millions of cellphones, tablets and computers available 24 hours a day, seven days a week, when people are most vulnerable," he said. "When they're alone or in isolation and within the close reach of minors, without regard for local authority or any reasonable time or spending limits."

This week's hearing yielded no vote, as it was purely informational, but the House Gaming Committee's chair, state Rep. Dan Didech, D-Buffalo Grove, indicated there would be a long road ahead for any iGaming legalization bid, calling opponents' concerns "well-founded."



committee hearing. "Again, it's probably obvious the most that AI does not have the ability to exercise ethical judgment or recognize when a person is in crisis, or adapt responses based on nonverbal cues and emotional tone — all the things that we're training our health care professionals to identify."

Morgan's other AI-related bill, House Bill 35, would change the way health insurance providers use AI to make decisions about customers' coverage. The bill passed out of the House Insurance Committee on an 11-6 vote on Tuesday.

Morgan outlined the bill's goal as "preventing inappropriate adverse determinations" from being taken against consumers. If HB35 is enacted into law, health insurers would be prohibited from solely relying on AI to deny, reduce or terminate coverage for patients. Instead, those AImade decisions would have to be "meaningfully reviewed" by a human employee who has the authority to override it.

Morgan said that every major health insurance provider currently is using AI in some way, both helpful and harmful to customers. Providers' use of AI to make coverage decisions for consumers without any oversight by real people is one of those harmful ways, he said.

"As we sit here today, insurance providers are using AI to decide what is going to be our health insurance claims," he said in the committee meeting. "We are completely blind to what that could be and how this be used against us and against our claims."

Late last year, ProPublica published an investigation on EviCore, a company that's used by a large number of major insurance companies in the United States, which found that the AI algorithm EviCore uses to make decisions about consumer's coverage has high denial rates.

"We have already seen large, nationwide insurance providers face class action lawsuits for relying on AI algorithms to deny life-saving care," Morgan said in the email to CNI, making reference to the lawsuits against Cigna, Humana and UnitedHealth Group, filed in recent years for their use of AI-driven decisions.

A lawsuit was filed against UnitedHealth Group in 2023, and a decision was reached just last month. Five of the seven counts were dismissed, Health Finance reported.

## Foster Introduces Legislation To Promote Political Spending Transparency For Investors

Congressman Bill Foster (D-IL) announced the reintroduction of the Shareholder Political Transparency Act. This legislation would amend the Securities Exchange Act of 1934 to require publicly traded companies to make quarterly disclosures to their shareholders detailing the types and amounts of political spending they engage in, ensuring greater transparency for investors and the public.

"Political contributions from publicly held companies should not be a secret, especially to people who invest their hard-earned money in them," said Foster. "This legislation is a commonsense measure that would provide investors with all the facts necessary to make informed decisions about where to put their money."

The Shareholder Political Transparency Act is cosponsored by Reps. Nydia Velázquez (D-NY), Joyce Beatty (D-OH), Sean Casten (D-IL), Chuy García (D-IL), Jan Schakowsky (D-IL), and Jim Himes (D-CT). already adopted policies that are stricter than the standards set forth in the bill, while other districts have not yet adopted any type of limitation on cell phone use.

## Illinois Human Trafficking Bill Focuses Cross-Agency Coordination, Victims

Leaders expect human trafficking numbers in state are higher than reports indicate

A Senate committee passed a bill this week that would give specialized training on human trafficking and establish coordination across multiple state agencies and partners.

Human trafficking is defined by the U.S. Justice Department as "a crime that involves compelling or coercing a person to provide labor or services, or to engage in commercial sex acts."

Senate Bill 2323 follows multiple recommendations from the state Joint Human Trafficking Working Group formed in 2023. The recommendations included victim screening, multi-agency coordination, victim-focused training and more.

Advocate and Chicago-native Brenda Myers-Powell, who was a victim of human trafficking for 25 years starting as a child, spoke at the state Capitol on Wednesday in support of the bill.

"I wish someone had recognized the signs when I was vulnerable," Myers-Powell said. "The expanded screening for youth in state care could have identified my situation before it escalated. The creation of standards of care means survivors like me won't have inconsistent, sometimes retraumatizing responses I encountered."

If the bill is implemented, multiple state agencies would have to make new units that work across jurisdictions and have specialized training to work with victims and potential future victims. "As a transportation hub, Illinois ranks among the highest in the number of human trafficking cases in the whole United States," Sen. Julie Morrison, D-Deerfield, the bill's lead sponsor, said Wednesday.

The Illinois Department of Children and Family Services, one of the agencies involved in the bill, would be required to maintain a human trafficking unit, which has the main goal of helping victims with case management and other services.

In a Senate committee hearing Tuesday, Illinois State Police Director Brendan Kelly said there were fewer than 600 victims of human trafficking reported to state agencies between 2021 and 2023. Another 966 possible cases of child trafficking were reported to DCFS over the same period. But Kelly said the reported numbers are likely only a fraction of the actual cases.

"We know that human trafficking exists in our state but is sometimes unrecognized, as victims aren't identified, and underlying crimes are unreported," Kelly said Wednesday.

Kelly said law enforcement knows how to recognize "the bad guy" but is not always as good at recognizing that the person with a perpetrator might be being victimized.

"We have to have a comprehensive approach to this so that ... when we encounter someone whoss a victim, that there is a handshake between law enforcement and all these social service providers because its simply not enough just to hand them a pamphlet or a phone number or just go on to the next bad guy," Kelly said Wednesday. "We have to break the cycle but making sure wesre better serving victims."

The bill also repeatedly mentioned improving "victim-centered, trauma-informed" responses from law enforcement and other agencies.

Kelly said training on the complex trauma of human trafficking and taking input from survivors like Myers-Powell will make combatting the problem easier.

However, it would not include school-issued devices or devices that students are required to possess or use for educational purposes.

The district policies would, at a minimum, prohibit the use of those devices during instructional time. But the policies would also have to allow exceptions that allow students to use them during emergencies or in response to an imminent threat to someone's health or safety.

The policies must also provide exceptions if the devices are needed as part of an individual educational plan for a student with disabilities, or if they are needed for medical care.

The new policies would have to be in place in time for the 2026-27 academic year.
